2023-2025 revenue requirement and rates compliance filing application

Corix Utilities (Foothills Water) Inc.

The Alberta Utilities Commission, the independent utilities regulator, will be considering Corix Utilities (Foothills Water) Inc.'s 2023-2025 revenue requirement and rates compliance filing application to ensure that the delivery of Alberta's utility service takes place in a manner that is fair, responsible and in the public interest.

Corix Utilities has filed an application requesting approval for its 2023-2025 revenue requirement and rate application compliance filing pursuant to the Commission's directions in Decision 27844-D02-2023.¹ Corix Utilities indicated that it has addressed all of the Commission's directions in the compliance filing notwithstanding its appeal and review application of Decision 27844-D02-2023 that is currently before the Commission.

If you feel you may be affected by this application, you can provide input to the AUC to review before it makes its decision. However, the purpose of intervening should be only to test Corix Utilities' compliance with Commission directions. The Commission will not permit parties to relitigate issues that were decided in Decision 27844-D02-2023.

Written submissions are due November 14, 2023.
